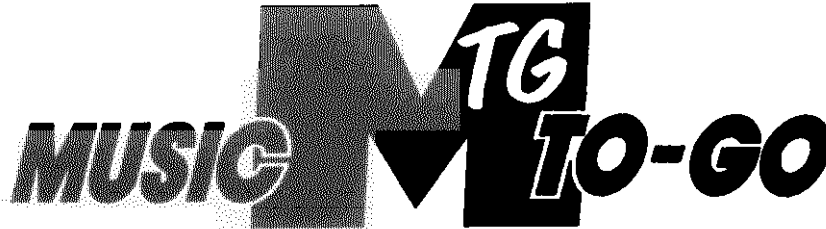

TERMS AND CONDITIONS

Music-To-Go works on a first come first serve basis. A deposit, along with a signed entertainment agreement will secure the date, if it is still available. Deposit is REFUNDABLE with a 90 day written cancellation notice less a \$25.00 service fee. In the event that a client cancels this agreement, with less than a 14 day written notice, Music-To-Go reserves the right to collect the balance owed. Client agrees to pay the balance due on or before the date indicated on this agreement. Out of state checks must be received fourteen days prior to the event. Client accepts full financial responsibility for loss or damage, caused by the client or guests, of any equipment provided by Music-To-Go at the event. Client agrees to pay a \$25.00 service charge to Music-To-Go as the result of returned checks. Music-To-Go requires access to the event location one hour prior to start time. Client agrees to provide sufficient electricity (15 amp 110/120 volts) within 50 feet of the disc jockey's equipment. For outdoor events, the client agrees to provide adequate weatherproof shelter. Should the disc jockey be forced to terminate performance due to weather that cannot be protected by the shelter, the client shall pay the full amount due, regardless of performance length. The legal and financial liability of Music-To-Go shall not exceed the deposit received from the client. Gratuity is not a condition of this agreement, however; it is appreciated by your disc jockey. By signing this agreement, the client agrees to all terms and conditions listed above.
