The cost of \$36.00 per person is based on a minimum of 30 people per coach and includes an experienced guide, a 46-passenger motor coach, admission at the Arch and either the tram or movie "Monument to the Dream", all arrangements and reservations.

August 25, 2006—tour to include a stop at Grant's Farm, lunch at Bevo Mill and a stop at Anheuser-Busch Brewery for the tour. Lunches must be pre-selected from two choices. They include the following: sautéed chicken, roast loin of pork, seasonal fish, sauerbraten. All are served with house salad, two vegetables, parsley potatoes, soft beverage and dessert. 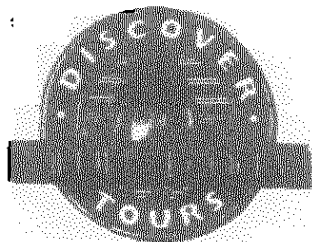
